The meeting on 27 January was delayed for some time due to lack of a quorum. The Jubilee committee is quite a large committee and the chairman would like approval from the delegates to lower the quorum needed to conduct business at a regularly scheduled meeting to: Chairman, Treasurer, and 3 other committee members, or the usual "greater than one half of uniquely tenanted positions present". A majority vote of the delegates should be sufficient to allow us that variance.

The bank balance is \$ 3,686.68. There is one outstanding check from the 44<sup>th</sup> Jubilee for \$ 47.16. The payee has been contacted and urged to cash the check.

Insurance - Mary Knoppe - Mary's written report suggested changing dues to \$10.00 beginning 2001.

Membership would be \$ 7.00 and Insurance would be \$ 3.00. Mary's report provided the following information:

A discussion ensued about next years dues amount. Finally, Barry suggested that he would make a recommendation to the Delegates that a minimum Club Dues amount should be \$81.00/year.

Public Relations - Vacant - No Report.

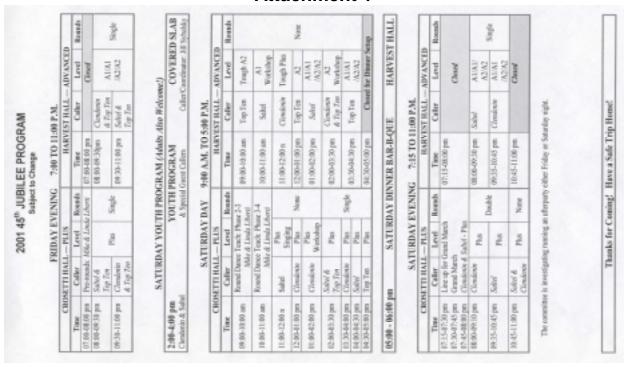
Fiesta Dances – Kindra Van Spyk – The 29 April Fiesta dance is cancelled.
