Delegates Meeting called to order at 3:00 p pm 20 July 2008. 7 of 12 voting clubs are in attendance.

Clubs not represented are: Blossom Hill Cloggers, Charley's Angels, Lucky Steppers, Silver Buckles / Carnival Twirlers, Single Squares of Sunnyvale, and Square Hoppers. New Delegates: Andrew Irish for El Camino Reelers.

Quorum at 2:50 pm. John Sybalsky appointed Parliamentarian.

Treasurer's report: (attached as PDF file). Transfer of accounts from BofA to Washington Mutual almost complete. We will keep ~\$2k in checking \$2-3k in Money Market account, and most in long term CDs. Jubilee account is also moved. The 3se are free checking accounts. Motion to submit the treasurer's report to audit. Passed.

President's Report: Distributed 2 checks for the 2008 State convention grand prize commissions Lucky Steppers \$76, Bows & Beaus for \$14. Barry is the Director in charge of Hospitality for 2009 National with 15-20 workers under him. 1<sup>st</sup> Vice President: We have been around a little bit. Attended CPSD graduation of 15 new dancers; visited Lucky Steppers. Attended Ice Cream Fling Thing June 6; danced with our home club the Star Eights.

Recording secretary: lost power for tape recorder. I am looking for it. Corresponding Secretary: Resignation letter received from Rockin' Jokers, Rosalie spoke with Lucky Steppers and Craig Veteran said that they were not renewing their membership. Two checks came in from Sunnyvale Singles, 9 envelopes with 52<sup>nd</sup> Jubilee ribbons.

## SCVCA Issues:

SCVCA Liaison: Keith thanks us for the support of the SCVCA Callers Appreciation dance. The dancers and association supported the dance and the callers appreciate it. The formation of the Joint committee was also a good step. Sam Shilmover sent a letter also expressing his appreciation, noting that Lucky Steppers left your association, encouraging association clubs to work to improve the association rather than leaving, and urging efforts at promotion. At the SCVCA meeting in June they approved participation on the Joint Committee: Keith Ferguson and Jerry Silverstein (with Jim Davis & Carol Glesser from SCVSDA). Keith emphasized the promotion of square dancing.

Joint Whing Committee: Jim Davis noted that the committee met last Thursday and discussed the Whing Ding and issues. We wanted to present this report at this meeting. Whereas: Whing Dings are useful to the local dancer population, the dancers' association,

and the callers' association. They provide dancers with opportunities to dance with local dancers from various clubs. They provide local callers a venue within which to perform, get exposure, and to work with other callers. They provide dancers with the experience of dancing to a variety of local callers.

Therefore the Joint Whing Ding committee recommends: that the SCVCA and SCVSDA work together to continue with Whing Dings; that the Joint Whing Ding Committee be instructed to develop and propose a revised contract; and that the two associations place Whing Dings under the direction of a continuing Joint Whing Ding Committee. Jackie recommended that the committee coordinate with the NCSDA, and that the October 31 date is questionable and may not be well attended. Recommendation from the board is to reject the motion that "the Whing Ding Contract between the SCVSDA and the SCVCA be terminated." Motion brought from the table, discussion. Motion failed. Contract is in force.

Barry instructs the committee to pursue its recommendation.

Insurance Chairmen's report, Betsy Lasarow-Tozzi & John Sybalsky Received 2009 rosters from ECR and Sunnyvale Singles, will turn them at the council meeting in August. Jackie feels we need to ensure we have a feedback loop to ensure that all dancers are covered. Jackie recommends that any club that has new club members since the 2008 roster was sent in should be proactive to confirm that those new members are covered.

ByLaws committee, John Sybalsky: Lots of people have been providing suggestions. John would like to invite a representative from each club on 3pm - 6 pm August  $2^{nd}$ . 2 pm - 5 pm Aug 3 invite any interested party. Plan to publish what Lorraine and what Joe have said. Hope to present proposal at the September meeting.

Asked at last meeting for authority to conclude contracts. Did we get such approval? The response is that contracts need to be reviewed by two officers of the SCVSDA, and signed by the president.

Approval of minutes of 18 May 2008: Moved Karl Belser, Lorraine seconds. Discussion Recommendation is to send out the minutes long in advance. Motion passed.

New business:

Appointment of nominating committee. Barry appoints Rosalie (Chairman), Lorraine, Andrew Irish to the nominating committee. Motion to by Lorrain Hlavka to eliminate Standing Rule 2D that candidates for President, 1<sup>st</sup> and 2<sup>nd</sup> Vice President must have previously served on the board. Second by Karl Belser. Question called. Call for the question passed. Motion 8 in favor, 2 opposed. Motion to delete Standing rule 2.d passed. **SCVSDA** Proposed Minutes Delegates Meeting 20 July 2008  $53^{rd}$  Jubilee: A few decisions need to be made about the  $53^{rd}$  Jubilee that will set the tone for the committee. Straw vote in favor of a  $53^{rd}$  Jubilee. If this is more than a rhetorical question then this question should go out to all the clubs. Mary notes that this \*is\* the forum for such discussions. Jerry notes that volunteers get stomped on and this makes others unwilling to volunteer. Motion by Karl Belser that we don't consider any changes to the bylaws until the Bylaws committee reports back. Second Carol Glesser. Joe Dehn raises a point of order, that this motion is out of order. Motion withdrawn. Is there a club to cosponsor Lorraine's suggestions.

Working with Ruth to get YR&R there (they will have a 10'x10' booth). Joe has the flyer rack. Need flyers from all clubs having classes. Indoor activities will be in Expo hall only. Our stage will be available any time we want to use it Fri, Sat, Sun 10a – 6p. We will try to have YR&R dancing intro sometime Friday, sometime Saturday. If other clubs would like to put on a demo they would be happy to have them. Joe is not recruiting for that. Please be proactive and contact Joe if you want to organize demos.

Announcements: Three hoedowns this weekend Single Squares of Sunnyvale & CPSD Aug 30 - Sep 1. 1pm – 4pm in interactive alley behind the Tech Museum of San Jose. Thanksgiving dinner dance. Jane Bishop of Star Eights moves that the association support the Thanksgiving Dinner dance Nov  $25^{th}$ , a fund raiser for the Salvation Army, she requests that this support include paying for the use of John Muir Middle School (~\$350). Mary Gingell seconds. Motion passed.
